

Call for the assignment of a contribution for the housing rental expenses incurred by SISSA “out-of-town” students for the year 2024 (MUR-MEF funds)

(Brief translation of the Director’s Decree n. 668 dated 07.08.2024)

Article 1

The call for applications for the allocation of a contribution for housing rental expenses incurred for the year 2024 by non-resident PhD students enrolled at SISSA is issued,

Article 2

The present announcement is open to SISSA PhD students enrolled for the academic year 2023/24 with a residency outside the Province of Trieste. Applicants for the allocation of a contribution for documented housing rental expenses incurred for the year 2024 must possess the following requirements:

- a) belong to a “family unit” with an equivalent economic situation index of no more than €20,000, with the possibility for PhD students to also avail themselves of the current ISEE;
- b) have a current ISEE certification;
- c) not to benefit - **apart from the housing contribution provided by SISSA which is to be understood as supplementary to that provided by the law cited in the introduction** - from “other public contributions for housing” in the reference year. This generally also means subsidies provided in the form of housing service, not only in the form of financial contribution, which also includes scholarships for “out of town” students, since it is composed, pursuant to art. 7, paragraph 2, of Legislative Decree no. 68/2012, also of costs relating to accommodation.

Article 3

The request for the benefit, must be sent to the email address phd@sisssa.it by **13:00 of 13 September 2024**, using the application form attached to this announcement.

Article 4

The list of beneficiaries will be published on the SISSA website, the PhD student may submit a request for rectification to the address phd@sisssa.it within 3 working days from the date of its publication. The Administration, with a reasoned provision, in the following 3 working days, may accept the request, reforming the list of beneficiaries, or reject it if it is unfounded.

Article 5

The Administration will verify *ex officio*, in collaboration with the “Agenzia delle Entrate”, the existence of the requirements for obtaining the contribution.

Without prejudice to the criminal sanctions provided for by art. 76 of Presidential Decree no. 445 of 28 December 2000, if the check reveals the untruthfulness of the content of the declaration, the declarant will lose the benefit.

Article 6

The Administration will communicate to the MUR by September 27, 2024 the number of those entitled to the contribution. The MUR, after having identified the per capita amount of the contribution in relation to the available resources and the total number of those entitled, will assign to SISSA a share of the national fund. After receiving the ministerial funds, the Administration will provide the contribution via bank transfer to the IBAN, indicated in the Esse3 application.

Article 7

For the purposes of Legislative Decree 30.06.03 n.196, and subsequent amendments and of European Regulation 2016/679 (General Data Protection Regulation), we inform you that all data provided to this Administration will be processed only for purposes connected and instrumental to the existing contract, in compliance with the provisions in force.

By submitting the application, the applicant gives his/her consent to the processing of personal data collected for the purposes identified in this announcement.

This generally also means subsidies provided in the form of housing service, not only in the form of financial contribution, which also includes scholarships for “out of town” students, since it is composed, pursuant to art. 7, paragraph 2, of Legislative Decree no. 68/2012, also of costs relating to accommodation;

- to be in possession of the receipt of the rental contract registration issued by the Agenzia delle Entrate and a copy of the contract itself;
- that the monthly rent is equal to € _____ and to be in possession of a copy of the relevant payment receipts for the rents paid in 2024 (tax receipts or bank transfer of the rental expenses incurred)

ALSO DECLARES TO BE AWARE

- that failure to submit the aforementioned documentation or the submission of an irregular document will result in the loss of the right to the ministerial contribution;
- that, as provided for in art. 5 of the competition announcement, SISSA reserves the right to verify the existence of the requirements for obtaining the contribution and request the submission of the documentation in the previous list;
- that the ministerial contribution and the SISSA supplementary contribution cannot in any way cumulatively exceed the rents paid in the year 2024, as resulting from the receipts or bank transfers of the housing rental expenses incurred.
